





- 6. Affidavit 2 (Affidavit of Property) (one per party)
- 7. Acknowledgment of Legal Representation
- 8. Filing Fee of \$200.00
- 9. <u>Decree of Dissolution</u> (needed for final hearing) (E-File as "Filing Submitted to Judge" in Word (.doc) format.)
